

## ~ Virginia Lifespan Respite Voucher Program ~ Application and Reimbursement Procedures

#### What is the Virginia Lifespan Respite Voucher Program?

The *Virginia Lifespan Respite Voucher Program* is funded through a federal grant awarded to the Virginia Department for Aging and Rehabilitative Services (DARS) from the federal Department of Health and Human Services, Administration on Aging --Office of Home and Community Based Services. The *Virginia Lifespan Respite Voucher Program* provides reimbursement vouchers to home-based caregivers for the cost of temporary, short-term respite care provided to individuals of any age with a disability or special need (children and adults, including elderly persons).

Individuals eligible to apply for voucher funding through the *Virginia Lifespan Respite Voucher Program* include Virginia caregivers of children or adults who reside in the same household as the person receiving care. Voucher funding is limited to a total of \$400 per family. All funds must be expended by July 31, 2013.

Respite funds must be requested by the primary caregiver who resides full time in the same household. Funds may <u>not</u> be used to reimburse household expenses or daycare; funds must be used to reimburse an individual respite care provider or an organization that provides respite. Due to limited funds, not all eligible applications will be approved. Please continue to read below for information on how to apply and what happens next if you are approved for funding through the *Virginia Lifespan Respite Voucher Program*.

#### How do I apply for funds for short-term respite care?

- 1. Complete the two-part *Virginia Lifespan Respite Voucher Application Form* and attach <u>proof of the individual's</u> disability/special need (see *Application Form* for a list of acceptable documents).
- 2. You may apply for voucher funding up to \$400 for reimbursement of respite care services, which must be used by July 31, 2013. You may apply for a voucher to reimburse expenses for respite care that will occur any time prior to July 31, 2013. You do not have to use the \$400 all at one time; it can be spread out over several periods of respite care (e.g., two or three weekends). For example, you may choose to use \$200 to offset the cost of a weeklong respite care program, and \$200 to reimburse the cost of an individual providing in-home respite for a weekend while you travel out of town. Note that you will only be reimbursed for actual expenses that are documented and submitted to DARS (see below).
- 3. The *Application Form* will be reviewed by DARS staff.\* You will be contacted within four weeks to inform you of the status of your application (approved or denied). You may be notified by e-mail, phone, or regular U.S. mail.

\*The application cannot be processed until all documentation and all forms are received and completed.

### If my application is approved, what happens next?

- If you are eligible for the *Virginia Lifespan Respite Voucher Program* and funds are still available, you will be contacted within four weeks to confirm your approval.
- DARS does not provide or arrange for respite care. YOU are responsible for selecting, hiring, and training a respite care provider of your choice, at a time that is convenient for you and your loved one. You may also use a community respite program (e.g., weekend respite program, therapeutic summer camp, adult day program). Respite and caregiver resources are available on the *Virginia Lifespan Respite Voucher Program* website at <a href="http://www.vadars.org">http://www.vadars.org</a> and on the Virginia Navigator website at <a href="www.virginianavigator.org">www.virginianavigator.org</a>.
- If you choose to select a respite care provider yourself, the individual selected to provide the respite care *MUST* be at least 18 years old and cannot be someone who currently resides in your home. You are also responsible for negotiating the rate of pay with the respite care provider you select.
- The DARS *Virginia Lifespan Respite Voucher Program* will send a check to you, the caregiver, to reimburse you for payment you have made to the selected respite care provider, not to exceed \$400/household (or whatever amount is requested and approved on your *Application Form*). You will be reimbursed only for actual expenses that are documented and submitted to DARS. You may pay more than the voucher amount you requested from DARS, but <u>you</u> will be responsible for making up the difference between the amount approved through the *Lifespan Respite Voucher Program* and what you have agreed to pay the provider. (For example, if your total respite cost is \$500, you will have to pay the additional \$100, since the maximum amount of voucher funding is \$400 through the *Virginia Lifespan Respite Voucher Program*.) Note that even if you have more than one person in your home who will receive respite services, the maximum amount is \$400 per family.
- Once you have identified a respite care provider or program, and the respite services have been used, you must complete a Virginia Lifespan Respite Voucher Reimbursement Form and a Virginia Lifespan Respite Voucher Satisfaction Survey. Both of these must be submitted to DARS within three months of date of approval or by July 31, 2013. Please mail to the address at the bottom of Page 1. The Reimbursement Form and the Satisfaction Survey, as well as the Application Form, can be found on the DARS website at <a href="http://www.vadars.org">http://www.vadars.org</a>.
- Reimbursement checks will be made payable to you, the primary caregiver, and <u>not</u> to the respite care provider! YOU are responsible for payment to your respite care provider. The reimbursement check will be mailed to the address you indicate on the *Reimbursement Form*.

NOTE: It can take up to 30 days from the date your Reimbursement Form is received by DARS to get your reimbursement check from the Virginia Lifespan Respite Voucher Program.
